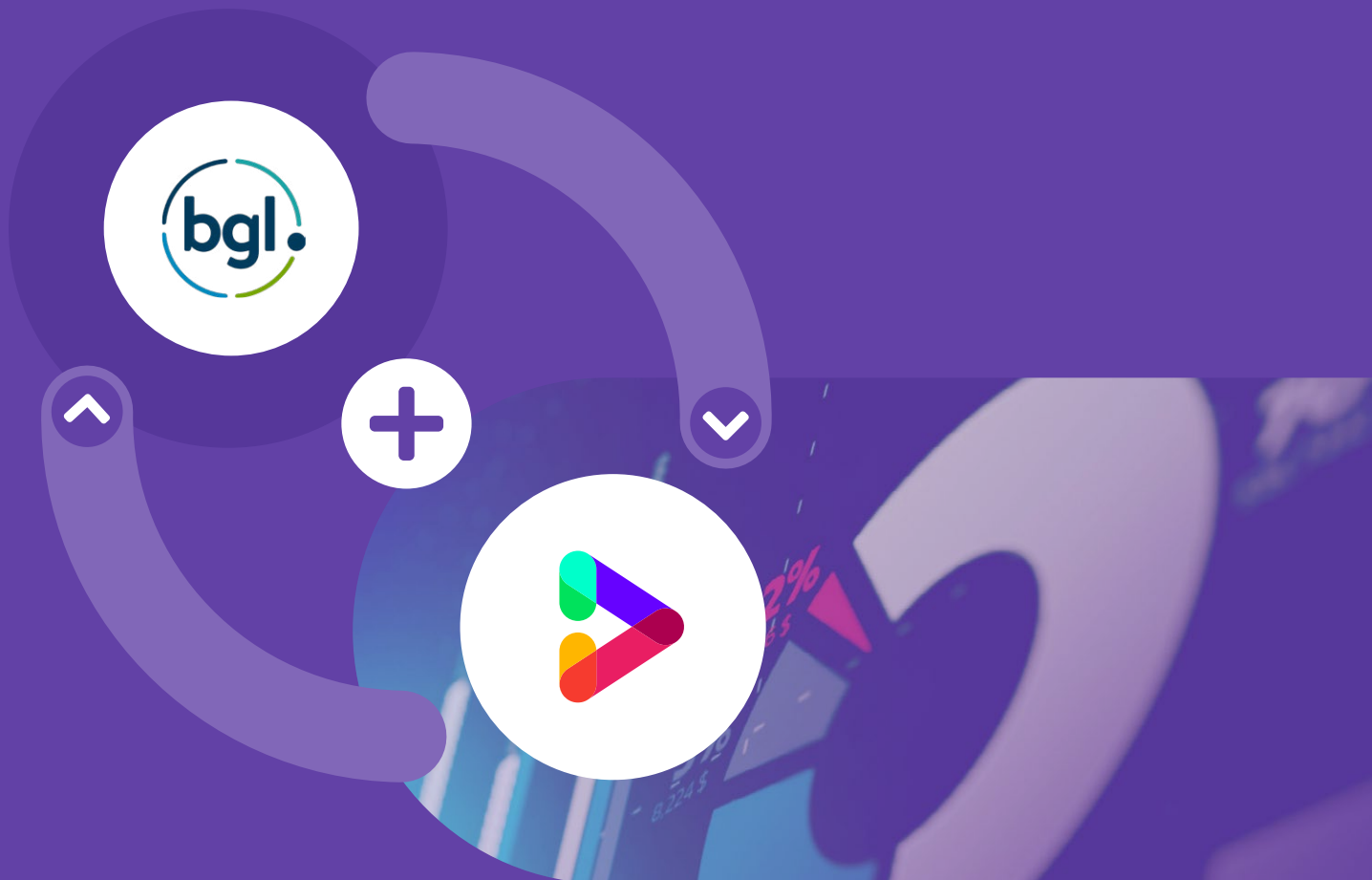

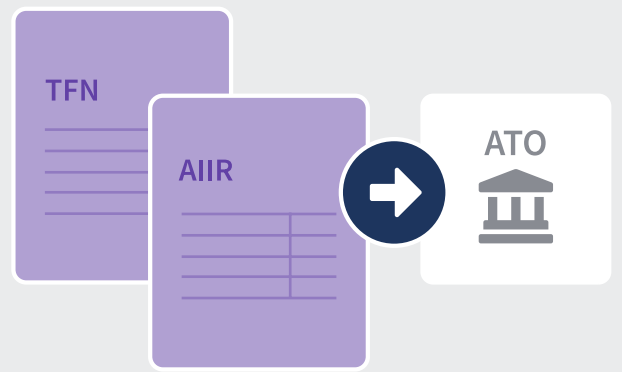
## Maintain compliance for unlisted and listed public companies

BGL CAS 360 generally meets the needs of most proprietary companies' ASIC reporting and ID verification requirements. However, unlisted and listed public companies have additional legal requirements which are not covered by CAS 360's functionality. These include providing TFN and AIRR reports to the Australian Tax Office, holding shareholder meetings, and calculating resident and non-resident withholding tax for dividend payments.

Registry Direct provides this functionality and more, empowering you to efficiently and professionally meet these obligations. Our integration feature allows you to import your CAS 360 data into Registry Direct, enabling you to use our platform to meet your full compliance obligations while easily maintaining data across both platforms.

## Our registry functionality includes

### ATO reporting

Our reports centre gives you quick and easy access to produce the reports the ATO requires unlisted and listed public companies to lodge, including:

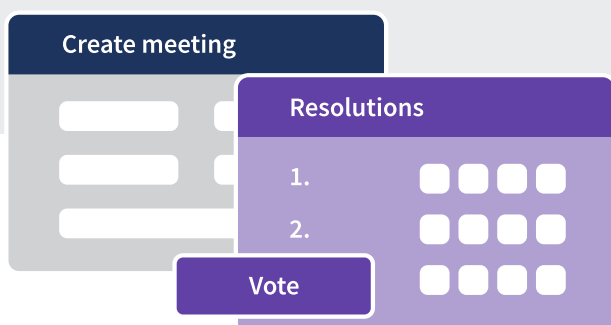
- **TFN reports.** Generate tax file number (TFN) reports each quarter.
- **AIIR reports.** Generate Annual Investment Income Report (AIIR) reports after each financial year, complying with the latest ATO specification.

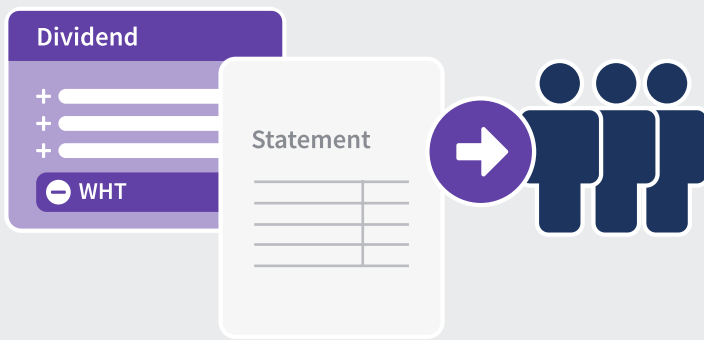
Both our TFN and AIIR reports are designed to be lodged directly into the ATO business portal.

### Shareholder meetings

Unlisted and listed public companies must also hold annual shareholders' meetings, and our meeting wizard makes it simple.

- Use the wizard to set up dates, locations and resolutions, manage voting directions and restrictions, and invite investors.
- Full flexibility between online and physical attendance.
- Comply with the Corporations Act by capturing investors' preferences for receiving notice of meetings.
- Allow investors to vote online or produce proxy forms in pdf format.
- Record results live and capture vote modifications in an audit log.





## Dividend payments

Step-by-step set-up of dividend payments includes the automatic calculation of resident and non-resident withholding tax, as required by law in payment statements.

- Pay distributions by generating an ABA file for your bank, or by cheque.
- Allot shares according to dividend redistribution plans.
- Generate and send payment statements by email or post, and manage retained or failed payments.

## Plus more

Our registry functionality also includes:

- **An investor centre.** Investors can maintain their own details and provide read only access to their advisers.
- **Shareholder communications.** Communicate with investors via email or post.
- **Capital raising.** Including professional online application forms, invoices and receipts.

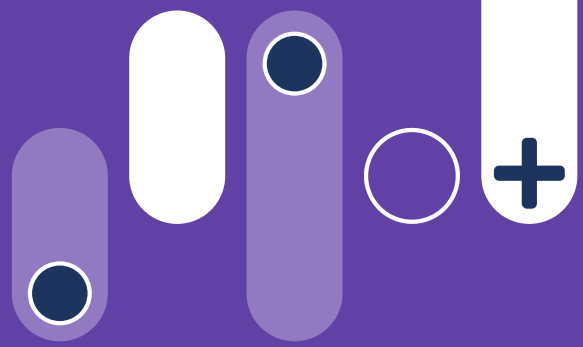
# BGL CAS 360 integration is easy to set up and easy to use

**Automated data import and reconciliation allows you to take advantage of both the BGL CAS 360 and Registry Direct platforms while maintaining synchronised data across both.**




Connect to BGL from your Registry Direct account and select which BGL companies you want to import. We will convert the company's security classes, holders and transactions into Registry Direct format. If you have a Registry Direct account already containing the company, you can match BGL security classes, holders and transactions with their Registry Direct counterparts.

Once a company has been imported or matched, we can check for any variances between BGL and Registry Direct data. A nightly reconciliation takes place and you can enable email notifications to be sent when variances occur. When a variance is found you can either correct the variance or mark it to be ignored.

BGL CAS 360 combined with Registry Direct integration is the simple solution for full compliance for unlisted and listed public companies.

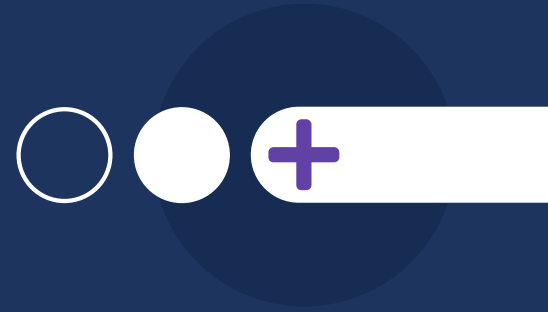
